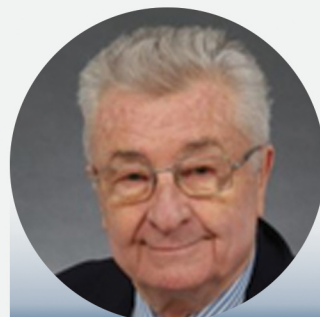

Nato je bil zaposlen na Fakulteti za organizacijske vede Univerze v Mariboru (1977-2010), kjer je predaval predmete Informacijski sistemi, Analiza in projektiranje organizacijskih sistemov ter E-poslovanje. Upokojil se je kot zaslužni profesor. Po upokojitvi raziskuje na področju razvijanja čezmejne e-regije in je koordinator zadevnega omrežja od leta 2010. V Sloveniji in mednarodnem okolju, kot tajnik nekaj omrežij, sodeluje v prizadevanjih za podporo aktivnemu staranju in razvijanju srebrne ekonomije z uporabo e-tehnologije.

Dr. Jože Gričar (<https://www.linkedin.com/in/joze-gricar-201799b/?originalSubdomain=sj>) was born in Novi mesto on April 17, 1941, where he graduated from high school (1960). He graduated (1964), obtained master's degree (1977) and doctorate (1984) at the Faculty of Economics of the University of Ljubljana. He was employed at Commerce Ljubljana, a representation of foreign companies (1965-1977) in various positions related to computer data processing. He was then employed at the Faculty of Organizational Sciences of the University of Maribor (1977-2010), where he taught the courses Information Systems, Analysis and Design of Organizational Systems, and eBusiness. He retired as an emeritus professor. After his retirement, he researches in the field of cross-border eRegion development and has been the coordinator of the relevant network since 2010. He participates in Slovenia's and international efforts to support active aging and the development of the silver economy by using eTechnology as



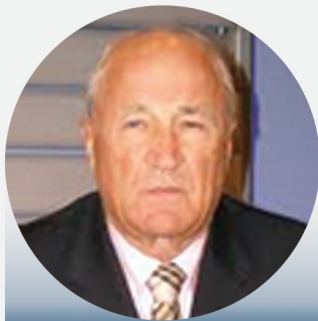

V času od 2010 do 2012 je deloval tudi kot vabljeni raziskovalec v Švici, na ETH Zürich in v podjetju Phonak, Stäfa. Je prejemnik nagrad za najboljši članek na treh mednarodnih znanstvenih konferencah in prejemnik priznanj za inovacije v slovenskem in evropskem okolju. Dr. Matjaž Debevc is a retired associated professor, researcher, consultant and external expert for European programs in Brussels. His areas of research and education are human-computer interaction, e-learning, visual communication, audio and video technology, and more recently the field of accessibility for persons with special needs. From 2010-2012 he also worked as an invited researcher in Switzerland, at the ETH Zurich and at Phonak, Stäfa. He is the recipient of awards for the best paper at three international scientific conferences and the recipient of awards for innovations in the Slovenian and European environment. He currently works as a national expert for the European Accessibility Resource Centre - AccessibleEU, as a coordinator of the Expert group on the accessibility for the World Federation of the Deaf, and as a member of various working groups in the field of accessibility at the University of Maribor and other institutions in Slovenia.

V sistemu COBISS ima vpisanih več kot 1700 bibliografskih enot. Je član Akademije pravnih znanosti Hrvaške in častni konzul Hrvaške. Je ustanovitelj prve zasebne zavarovalnice v Sloveniji in na Hrvaškem. Prejel je nagrado za življenjsko delo od Zveze društev pravnikov Slovenije.

Šime Ivanjko, prof. Emeritus, dr. sc. was a long-time professor at the Faculty of Law of the University of Maribor for economic and insurance law and ethics and society. He was dean several times and also served as vice-rector. He was educated at the Faculties of Law in Ljubljana, Zagreb, and Hamburg. He also lectured at the University of Rijeka and Zadar (HR). Cobiss has more than 1,700 bibliographic items registered, written by the professor in the Slovenian national bibliographic records. He is a member of the Academy of Legal Sciences of Croatia and Honorary Consul of Croatia. Founder of the first private insurance company in Slovenia and Croatia. He received the Lifetime Achievement Award from the Association of Law Societies of Slovenia.

Dr. Silvo Devetak je brez dvoma eden najbolj vizionarskih znanstvenikov, družbenih in političnih akterjev, čigar akademsko delo, pa tudi civilnodružbene pobude so v veliki meri prispevali k evropski integraciji Jugovzhodne Evrope in evropskemu integracijskemu procesu kot celoti. Erhard Busek, nekdanji avstrijski podkacler, je v liber amicorum, objavljenem ob njegovi 80-letnici, zapisal, da so njegove ideje, vizije in obeti še posebej potrebni v današnjem svetu. Devetak je bil ustanovitelj in predstojnik Katedre za mednarodno pravo in mednarodne odnose na Pravni fakulteti Univerze v Mariboru. Poleg tega je ustanovil Evropski center za etnične, regionalne in sociološke študije-ECERS, ISCOMET – Inštitut za etnične in regionalne študije ter mednarodno nevladno organizacijo ISCOMET, ki ima participativni status pri Svetu Evrope. Leta 1997 mu je Vlada Republike Slovenije podelila naziv »Ambasador znanosti Republike Slovenije«. Leta 2016 je postal zaslužni profesor Univerze v Mariboru. Silvo Devetak je od leta 1993 uspešno izdelal in koordiniral več kot 17 mednarodnih akademskih projektov, ki so obravnavali različne vidike politik EU v različnih evropskih regijah. Prvi (Vloga religij v procesu miru v JVE) je bil leta 1994 dodeljen ISCOMET-u s sklepom Evropskega sveta. Njegova bibliografija obsega več kot 630 enot.

»Without doubt, Silvo Devetak is one of the most visionary scientists, social actors and political players whose academic work, as well as civil society initiatives, has contributed to a great extent to the European integration of South Eastern Europe and the European integration process as a whole. His ideas, visions and prospects are especially needed in today's world« wrote Erhard Busek, former Vice-Chancellor of Austria in the liber amicorum published at his 80 anniversary. Devetak was the founder and head of the Department of international law and international relations at the Faculty of law, University of Maribor. Besides, he founded the European centre for ethnic, regional and sociological studies – ECERS, ISCOMET- Institute for ethnic and regional studies and the ISCOMET international NGO, which enjoys a participatory status with the Council of Europe. In 1997, the government of Republic of Slovenia awarded him with the title "Ambassador of science of the Republic of Slovenia". In 2016, he became a Professor Emeritus of the University of Maribor. Silvo Devetak since 1993 successfully elaborated and coordinated more than 17 international academic projects dealing with different aspects of EU policies in different European regions. The first one (The role of religions in the process of peace in SEE) was in 1994 allotted to ISCOMET with the decision of the European Council. His bibliography comprises more the 630 items.

Dr. Rudolf Pušenjak se je rodil 21. januarja 1947 v Ljutomeru. Leta 1972 je diplomiral na Fakulteti za elektrotehniko UL, leta 1982 magistriral in leta 1988 doktoriral. Po diplomi je bil zaposlen na IEVT v Ljubljani, od leta 1993 dalje pa na Fakulteti za strojništvo UM, kjer je postal docent, kasneje pa izredni profesor. Do upokojitve je predaval predmete s področja elektrotehnike in avtomatizacije, v sonosilstvu pa tudi predmet podiplomskega študija Mehanika objektov in procesov. Je avtor številnih SCI člankov v mednarodnih znanstvenih revijah in avtor številnih učbenikov. Do upokojitve je bil sodelavec, nosilec in vodja programske skupine na področju mehanike. Bil je član številnih mednarodnih znanstvenih združenj, je aktivni član PAZU ter član DAP. Po upokojitvi je na Fakulteti za logistiko UM predaval na podiplomskem študiju in v soavtorstvu izdal učbenika Osnove modeliranja dinamičnih procesov v logistiki I in II. Redni profesor za predmetno področje Elektromehanski sistemi je postal na Fakulteti za industrijski inženiring Novo mesto, kjer je predaval številne predmete na dodiplomskem in podiplomskem študiju in s soavtorjem, prof. dr. M. Oblakom, izdal učbenik Nihanja mehanskih sistemov. Na tej fakulteti je še nadalje raziskovalno in pedagoško aktiven in je za svoje delo leta 2019 prejel naziv zaslužnega profesorja.

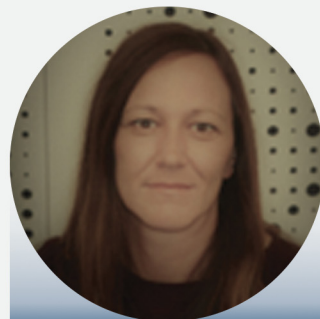
Rudolf Pušenjak was born on January 21, 1947 in Ljutomer, Slovenia. In 1972, he graduated from the Faculty of Electrical Engineering of UL, where he obtained master's degree in 1982, and PhD in 1988. After graduation, he was employed at IEVT in Ljubljana, and from 1993 on at the Faculty of Mechanical Engineering of UM as assistant professor and associate professor. Until retirement, he taught subjects of electrical engineering and automation, and the postgraduate subject Mechanics of Objects and Processes. He is author of numerous SCI articles in international scientific journals as well as textbooks. He was an associate, holder and head of the program group of mechanics and member of many scientific associations, active member of PAZU and DAP. After retirement, he taught Master's courses at the Faculty of Logistics of UM and co-authored the textbook Fundamentals of Dynamic Process Modeling in Logistics I and II. He became full professor at the Faculty of Industrial Engineering in Novo mesto, where he taught subjects in undergraduate and postgraduate studies and coauthored with prof. PhD M. Oblak textbook Oscillations of mechanical systems. At this faculty, he is still active in research and teaching and in 2019 received the title of professor emeritus.

Dr. Danijela Lahe je docentka na Oddelku za sociologijo Filozofske fakultete Univerze v Mariboru. Raziskovalno se ukvarja s področjem družine, izobraževanja in socialne gerontologije, s poudarkom na starizmu in medgeneracijskem sodelovanju.

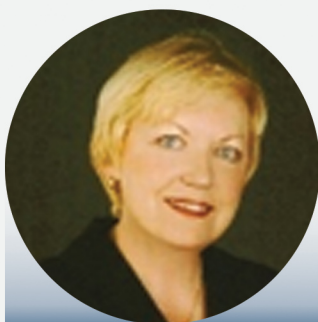

Vlada RS jo je imenovala za državno sekretarko za visoko šolstvo na MIZŠ RS (2003-2004). Od leta 2011-2018 je opravljala funkcijo prorektorice za razvoj kakovosti na UM in aktivno sooblikovala zunanji in notranji, tako programski kot institucionalni sistem zagotavljanja kakovosti visokošolske dejavnosti. Aktivno je sodelovala pri presojah kakovosti v visokem šolstvu (NAKVIS) in pri Evropskem združenju univerz (EUA), kjer je članica ekspertne skupine evalvatorjev (IEP EUA). Vlada RS jo je leta 2014 imenovala za predstavnico v OECD UO IMHE in za predsednico Sveta za visoko šolstvo RS.

Assoc. prof. Lučka Lorber, PhD, was the Vice-Rector for Quality Development of the UM (2011-2018), responsible for the implementation of adopted policies for a sustainable and socially responsible university. She has been a part of the University of Maribor since 1994, first working in the university administration, and later moving as a geography professor to the Department of Geography of the Faculty of Arts. She continues to develop her skills and expertise by cooperating in various European projects and as a visiting professor at different European universities. She is a member of several editorial boards of national and international journals. In the period 2003-2004, she served as the State Secretary for HE at the Ministry of Higher Education and Sport, appointed by the Government of the Republic of Slovenia. Due to her expertise in Slovenian and international higher education, Professor Lorber is a regular member of higher education quality evaluation bodies (NAKVIS) and the European University Association, where she serves as a member of the Institutional Evaluation Programme (IEP). In 2014, the Government of the RS appointed Professor Lorber as the Slovenian representative to the OECD (IMHE). In the same year, she was appointed as the Chair of the Slovenian Council for HE.

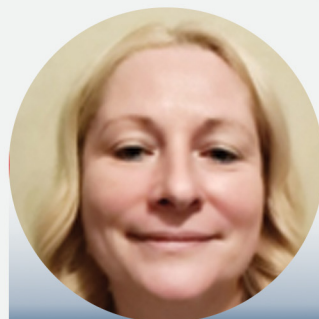

Zaslužni profesor ddr. Matjaž MULEJ, rojen leta 1941, je doktor ekonomskih znanosti in doktor menedžmentskih znanosti. Deluje zlasti na Ekonomsko-poslovni fakulteti UM in v IRDO – Inštitutu za razvoj družbene odgovornosti. Je mentor 26. doktorjem in 62. magistrim. Bil je gostujoči profesor in raziskovalec v tujini 15 semestrov. V obdobju 1997-2001 je bil dekan in prorektor Univerze v Mariboru. Od l. 2006 se ukvarja s teorijo in aplikacijo družbene odgovornosti v okviru Inštituta IRDO (www.irdo.si). Je član v treh Akademij znanosti in umetnosti, Evropski v Salzburgu (2004), Evropski v Parizu (2004), in IASCYS, za sistemske in kibernetične vede (Dunaj, 2010, zdaj Pau, Francija, častni ustanovni predsednik), kandidat tudi za SAZU. V International Federation for Systems Research (IFSR) je bil podpredsednik (2002-2006) in predsednik (2006-2010). Za delovanje na omenjenih področjih je dobil priznanja v Jugoslaviji, Sloveniji, Mariboru, na Univerzi v Mariboru in IRDO ter WOSC kot eni od najstarejših mednarodnih organizacij za teorijo sistemov in kibernetiko. Objavil je okoli 2.500 tekstov v skoraj 50 državah, med njimi skoraj sto soavtorskih knjig in zbornikov. ResearchGate poroča o skoraj 110.000 branjih, Academia o preko 2.600 citatih. Je avtor dialektične teorije sistemov, teorije inovativnega poslovanja in modela inovativne trajnostne družbene odgovorne družbe (s soavtorji).

Matjaž MULEJ, 1941, Slovene, holds a Doctor of Economic Sciences (in the field of systems theory) and a Doctor of Management Sciences (in the field of innovation management), emeritus professor of systems theory and innovation (since 2001). He works in particular at the Faculty of Economics and Business of the UM and at the IRDO - Institute for the Development of Social Responsibility. He was the mentor of 26 doctors and 62 masters. He was a visiting professor and researcher abroad for 15 semesters. He was dean and vice-rector of the University of Maribor (1997-2001). He is a member of three Academies of Sciences and Arts, European in Salzburg (2004), European in Paris (2004), and IASCYS, for system and cybernetic sciences (Vienna, 2010, now Pau, France, honorary founding president); candidate also for SAZU. In the International Federation for Systems Research (IFSR), he was vice-president (2002-2006) and president (2006-2010). For his work in the aforementioned fields, he received virtually all possible awards in Yugoslavia, Slovenia, Maribor, the UM and IRDO and WOSC as one of the oldest international organizations for systems theory and cybernetics. He published almost 2.500 texts in almost 50 countries, including almost 100 co-authored books. ResearchGate reports almost 110.000 readings, Academia on 2.600 citations of him. He authored the Dialectical Systems Theory, innovation management theory, and innovative sustainable socially responsible society model (with coauthors).

Urška Gruden, specialistka menedžmenta v izobraževanju in andragoginja, je koordinatorica projekta Vseživljenjsko učenje, trajnostni razvoj in dolgoživa družba: razvoj vsebin, strategij in evalvacije ter sistema mikrokreditov za starejše odrasle na Centru za pedagoško izobraževanje Filozofske fakultete v Ljubljani. Raziskuje in razvija programe za izobraževanje učiteljev za različna starostna obdobja.

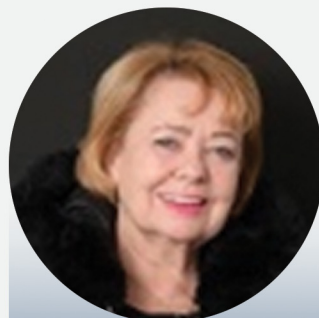

V 40. letih dela je svojo poklicno in akademsko kariero posvetil kroničnim degenerativnim boleznim in razvoju rehabilitacije gibalnih motenj. Leta 2005 je postal redni profesor in predstojnik Katedre za fizikalno medicino in rehabilitacijo na Medicinski fakulteti Univerze v Mariboru. Tam je vodil raziskave na področju rehabilitacije v revmatologiji, gerontologiji in integrativni medicini. Na podlagi odmevnosti mojega raziskovalnega in strokovnega dela je postal član Evropske akademije znanosti in umetnosti, Medicinske akademije Slovenije in Medicinske akademije Hrvaške. Poleg več podeljenih priznanj, med katerimi so Red za zasluge Republike Slovenije, Zlata plaketa Univerze v Mariboru in Bronasti grb mesta Maribor, je prejel tudi strokovna priznanja, kot so Zaslužni član Zdravniške zbornice Slovenije in častni član Slovenskega zdravniškega društva. Trenutno kot zaslužni profesor predava na različnih akademskih ustanovah v Sloveniji.

A graduate of medicine from the Medical Faculty, University of Rijeka (1971), I continued postgraduate education at the Medical Faculty, University of Zagreb (MSc, 1985 and PhD, 1998). As specialist of physical medicine and rehabilitation, as well as rheumatology, I founded and led the Department of Physical Medicine at the University Clinical Centre of Maribor. In my 40 years of work, I dedicated my professional and academic career to chronic degenerative diseases and development of the rehabilitation of locomotory disturbances. In the year 2005, I became full professor and Chair of Department of physical medicine and rehabilitation at the Medical Faculty, University of Maribor. There, I have been leading research in the field of rehabilitation in rheumatology, gerontology, and integrative medicine. 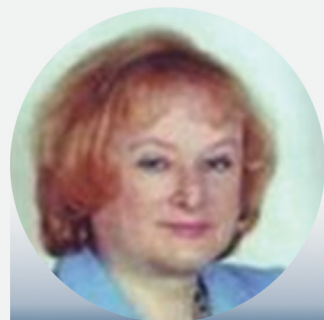

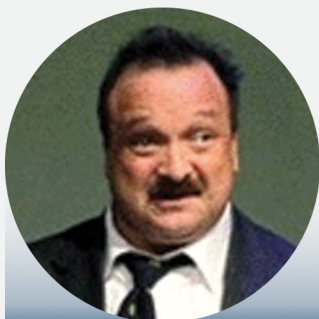

In 2008, she became a member of the University of Maribor's Faculty of Arts, which was established in 2006, where she and her colleagues founded the Department of Art History. She was the head of the Department of Art History until 2015, and she retired in 2017. In 2020, she received the Miklošič Award for research and teaching at the Faculty of Arts, University of Maribor. Her research focuses on castle furnishings, with a particular interest in the issue of tapestries; she also studies more recent fine art, especially in the area of north-eastern Slovenia.

Red. prof. dr. Matjaž Klemenčič se je rodil 13. septembra 1955 v Ljubljani. V letih od 1983 do 2020 je bil član oddelka za zgodovino na Univerzi v Mariboru; od leta 1998 kot redni profesor. Bil je vodja številnih projektov in programa P6-0372 ARRS. Sodeloval je v številnih mednarodnih projektih. Je avtor desetih knjig in preko stotih izvirnih znanstvenih člankov, ki jih je objavil v Sloveniji ter evropskih in izvenevropskih državah. Predaval je na vseh štirih slovenskih univerzah ter na Colorado State University. Bil je mentor pri desetih dokončanih doktoratih. Bil je Fulbrightov štipendist in Zoisov nagrajenec. Trenutno je član programske skupine Manjšinske in etnične študije ter slovensko narodno vprašanje na Inštitutu za narodnostna vprašanja v Ljubljani; honorarno pa predava na Univerzi v Novi Gorici.

Prof. dr. Matjaž Klemenčič was born on September 13, 1955 in Ljubljana. From 1983 to 2020, he was a member of the History Department at the University of Maribor; since 1998 as a Professor. He led many Projects and the P6-0372 ARRS program. He participated in many international projects. He is the author of ten books and over a hundred original scientific articles, which he has published in Slovenia and in European and non-European countries. He lectured at all four Slovenian Universities and at Colorado State University. He was the mentor of ten completed doctoral theses. He was a Fulbright scholar and a Zois laureate. He is currently a member of the Program group Minority and Ethnic Studies and the Slovenian National Question at the Institute for Ethnic Studies in Ljubljana; and lectures part-time at the University of Nova Gorica.
